Cyber Police Kashmir Busts Major Mule Account **Network Fueling Cyber Frauds, 21 Arrested**

The Cyber Police Station, Kashmir Zone, Srinagar, has uncovered a vast and sophisticated network behind the creation and operation of mule bank accounts a key enabler in large-scale cyber frauds and financial crimes.

Police said that it has identified

7.200 mule bank accounts operating from the Kashmir Valley alone, created since January 2025. As many as 21 individuals, 19 of whom belong to Srinagar district, have been arrested during the investigation of four FIRs registered by the Cyber Police. elevated India's cooperative sector to global prominence, especially in the field of Nano Urea and Nano DAP, which are now being exported worldwide.

He further noted that the cooperative has enhanced its capacity, expanded its outreach to farmers' fields, and successfully translated laboratory research into field-level applications.

Marking the foundation of the Beej Anusandhan Kendra in Gandhinagar, Shah said Prime Minister Narendra Modi has launched several innovative ventures across various sectors in the country.

He stated that under the Prime Minister's leadership, the Ministry of Cooperation has undertaken nearly 62 unprecedented initiatives in the cooperative sector.

Shah also mentioned that Parliament recently passed a bill to establish the Tribhuvan Sahkari University, named in honour of Tribhuvandas Patel's contributions to the cooperative movement.

He explained that this university aims to deliver modern cooperative education and ensure transparencv across all cooperative levels-from Primary Agricultural Credit Societies (PACS) to apex bodies.

Shah shared that IFFCO currently operates production units in five locations across three states-Kandla, Kalol, Phulpur, Aonla, and Paradip.

He further revealed that the organization's current fertilizer production capacity stands at nine million metric tons, with sales reaching 11 million metric tons. IFFCO has achieved a turnover of Rs 40,000 crore and a profit of Rs 3,200 crore.

Several dignitaries, including Gujarat Chief Minister Bhupendra Patel and other notable figures, were present on the occasion.

Cyber Police Kashmir... transfer illicit funds on behalf of others, often in return for a commission. These accounts—belonging to individuals, shell companies, and enterprises-are primarily scouted through social media platforms such as Telegram and Facebook, and are then remotely controlled by fraudsters operating from outside Jammu & Kashmir and even from overseas.

Once these accounts are set up, they are integrated into illegal payment gateways and used by criminal syndicates to collect deposits from victims on fake investment websites, offshore betting and gambling platforms, and fraudulent stock trading portals. Funds received in these mule accounts are immediately lay-

ered and diverted to other accounts or converted into cryptocurrency to obscure the money trail.

Bulk payout facilities provided by banks are also being misused in this process to distribute proceeds quickly.

These accounts typically remain active for a short span, often less than a week—before being flagged due to suspicious transactions. However, within this brief window, transactions worth crores of rupees are executed and funneled across a chain of accounts, Senior Superintendent of Police, Srinagar, Imtiyaz Hussain said during a press conference.

He said Cyber Police Kashmir has also discovered that several local kingpins are managing the operations of these accounts, acting as recruiters and han-

"These individuals onboard people, often from economically weaker sections, by offering commissions for account access," he said.

SSP said in response to a request by Cyber Police Kashmir, the Indian Cyber Crime Coordination Centre (i4C), MHA, New Delhi has shared a list of 7,200 mule bank accounts operating from the Kashmir Valley alone—created since January 2025.

"This figure is expected to be much higher as the investigation progresses," he said.

He added that the hotspots for mule account activity include areas like Mehjoor Nagar, Natipora, Nowgam, Lasjan, Padshahibagh, Nowhatta, Khanyar, Rainawari, Soura, Batmaloo, Noorbagh, Qamarwari, Parimpora, Mujgund, Bemina, among others. Similar activities have been reported in other districts including Ganderbal, Kangan, Sumbal, Bandipora, Baramulla, Pulwama, Anantnag, Kulgam, and Shopian.

Cyber Police Station Kashmir Zone, Srinagar, has strongly advised citizens not to sell or rent their bank accounts, company registration certificates, or Udhyam Aadhaar registration documents to any individual or entity. Any such involvement in laundering illicit funds could result in serious legal consequences, including arrest under provisions related to organized crime and cyber fraud.

Talking with PTI here after paying obeisance at the revered Mata Vaishno Devi Shrine atop Trikuta hills on the occasion of Ram Navami, the National Stock Exchange (NSE) chief said it seems that the Indian share market is doing much better than other countries post the US decision on reciprocal tariff.

"It seems that India's position is a bit heavy compared to other countries," he said.

"A situation of confusion persists as of now. Many feel that some companies may face more losses. But overall, there will be negotiations and the duty structure will be stabilized. The situation should be clear in the next one or two weeks," he said.

Key stock market indices Sensex and Nifty declined over 2.5 per cent last week, dragged primarily by weak global cues and renewed concerns over a trade war after the US tariffs.

The institute has also developed safer and more effective agrochemicals, and its work in catalysis has led to novel catalysts for hydrogenation, oxidation, and polymerization processes used widely in industrial applications.

Dr. Reddy highlighted CSIR-IICTs key achievements including the development of compostable plastics in association with GreenWorksBio. He also highlighted the development of Hydrazine Hydrate in collaboration with Gujarat Alkalies and Chemicals Limited (GACL). In the domain of sustainable technologies, the institute's Anaerobic Gas Lift Reactor (AGR) technology enables efficient conversion of biodegradable waste into biogas and bio-manure.

Dr. Vinay Nandicoori, Director of CSIR-CCMB, elaborated on the institute's accomplishments in molecular biology, genetic diagnostics, and biotechnological innovation. He highlighted that CCMB was the first Indian institution to develop DNA fingerprinting technology, which has had a lasting impact on forensic investigations and legal proceedings in the country. During the COVID-19 pandemic, the institute responded swiftly by developing indigenous diagnostic kits, surveillance systems, and even advancing mRNA vaccine technologies.

One of CCMB's most impactful initiatives has been its work on sickle cell anemia, under which it developed a highly sensitive, low-cost diagnostic kit as part of the National Sickle Cell Elimination Mission.

The institute is also engaged in research on diseases like tuberculosis and encephalitis and has launched India's first rare disease registry to better understand the genetic basis of uncommon disorders. Through its Atal Incubation Centre (AIC-CCMB), the institute has nurtured more than 160 startups working on biotech innovations in healthcare, agriculture, and environmental sustainability.

In the realm of conservation, CCMB continues to lead studies on the genetic diversity of endangered species, such as tigers and olive ridley turtles, and supports wildlife forensics to curb illegal poaching and trade. Dr. Nandicoori emphasized the institute's dual commitment to fundamental research and societal application, bridging deep science with real-world outcomes.

Dr. Prakash Kumar, Director of CSIR-NGRI, presented the institute's significant achievements in earth sciences, particularly in the areas of seismic hazard mapping, resource exploration, and infrastructure support. He noted that NGRI has developed India's first strain map to assess earthquake vulnerability in the Himalayan and Indo-Gangetic regions, a critical step toward national disaster preparedness. The institute is also conducting deep seismic profiling under a national program aimed at decoding the crustal structure of central India, which holds implications for both tectonic studies and mineral exploration. NGRI's work on geothermal energy, particularly in Ladakh and Chhattisgarh, has opened new frontiers for clean and renewable energy.

Dr. Jitendra Singh appreciated the vital role played by the CSIR laboratories in driving scientific innovation, supporting national missions, and contributing to India's goal of becoming a self-reliant knowledge economy. He emphasized the importance of sciencebased solutions for national development, especially in addressing societal challenges and promoting sustainability. The Minister said that Hyderabad has emerged as a thriving ecosysytem for scientific research, innovation, and entrepreneurship.

In light of the contributions of these three institutes during the meeting it was decided to organize a CSIR Startup Conclave in Hyderabad. The event, scheduled for April 22-23, 2025, aims to facilitate collaboration between research institutions and startups, and promote entrepreneurship in India. The conclave will be organized jointly by CSIR-IICT, CSIR-NGRI, and CSIR-

on regulatory measures adopted by the Health Department to ensure compliance with the Act across registered ultrasound facilities in the district. Deputy Commissioner Sharma emphasized that preventing sex-selective practices remains a top priority for the district administration. "Regular and random inspections of ultrasound clinics must be conducted to ensure strict adherence to all provisions of the PCPNDT Act," directed the DC, who also serves as Chairman of the District Advisory Committee.

In a strategic approach to enhance grassroots vigilance, the DC proposed that future DAC meetings be conducted in areas identified as vulnerable to violations. He also recommended developing more effective awareness tools and increasing community participation through active involvement of Committee

The meeting witnessed participation from key officials representing stakeholder departments including Health, Social Welfare and Legal Advisory, who collectively pledged to intensify efforts to eliminate sexselective practices through rigorous implementation of the Act.

The Pre-Conception and Pre-Natal Diagnostic Techniques Act aims to prevent the misuse of prenatal diagnostic procedures for sex determination, which can lead to female feticide. The Act prohibits sex selection before or after conception and regulates prenatal diagnostic techniques for detecting genetic or metabolic disorders or chromosomal abnor-

Under the combined leadership of the Army Wives Welfare Association (AWWA) and the Residents Welfare Association (RWA), an array of eco-friendly innovations has reshaped Varanasi Cantonment into a cleaner, greener, and more dynamic environment. This milestone transformation aligns seamlessly with the broader mandates of Swachh Bharat Abhiyan and the Fit India Movement.

Ban on Single-Use Plastics and 'Thaila Ghars' Early last year, the AWWA banned single-use plastic and polythene. Thaila Ghars' have been introduced to provide cloth bags made from donated fabric at station gates and shops, thereby reducing reliance on plastics. In tandem, Boxes of Kindness' collect clothing and toys for underprivileged recipients, with unusable garments repurposed into additional cloth bags for widespread use.

Waste Management at the Source

To strengthen good waste-management pracrobust Information, Education, and Communication (IEC) campaign has cemented segregation at the household level. Blue, Green, and red bins are allocated for wet, dry, and bio- hazardous waste respectively. Battery-operated collection vehicles begin their rounds at dawn, broadcasting Swachh Bharat messages and minimising



dependence on roadside bins. This approach ensures safer disposal and better protection for sanitation workers.

Incentivising Responsible Disposal

Interlocking PET tiles, made from waste plastic, provide durable, anti-skid Eco-bricks walkways. plastic bottles stuffed with polythene are used to build benches, sculptures, and seating areas, showcasing a functional circular economy. Meanwhile, bio-toilets constructed from recycled plastic feature

Addressing a longstanding need for a communal venue, 39 GTC revitalised older barracks to create a air-conditioned, solar-powered auditorium overlooking "Phewa Taal." Equipped with a 55 KW rooftop solar project (including 30 kW off-grid), the facility reduces electricity costs and offers a comfortable setting for film screenings, lectures, and gatherings, free from humidity and intrusive noise.

Harnessing Solar Battery-Energy and Operated Fleet

Rooftops and vacant areas within the cantonment have been surveyed for optimal solar-panel placements. A broad fleet of zero-emission vehicles now includes garbage-collection e-vehicles, mini fire tenders, pump platforms, garden- squad vans, ebakery vans, e-carts, eambulances, e-scooters, and e-cycles, significantly lowering the cantonment's carbon footprint.

This integrated effort recognises Varanasi's critical pollution levels, as flagged by the CPCB and

Modern, Eco-Friendly Facilities

Renovation of 38 toiletwashroom complexes follows green-building principles, focusing on ventilation, water conservation, and hygiene. Food packaging waste, Tetra Packs, wrappers processed into fire-retardant 'plast ply' sheets used for sentry posts and launderette roofs. A 1000 L/h Reverse Osmosis plant in family lines eliminates the need for individual units, and the 'Green Laundrette' demonstrates how to recycle RO discharge water efficiently. A refreshed JCO/OR Transit Facility provides modern, morale-boosting amenities for personnel.

Holistic Water and Waste Solutions

Filtration tanks with iron grids and twin-chambers of charcoal and sand remove debris from incoming sewage, while Gambusia fish control mosquito larvae. Flow from the railway STP powers turbines that generate hydroelectricity for a natural walkway. Updated cookhouses, strengthened weigh-and-account procedures, reduce wastage and employ biomethanation to convert kitchen refuse into LPG. 

SC Slams Verdict

The Supreme Court on Wednesday stayed the shocking, insensitive and inhuman order of the Allahabad High Court which said that holding the private parts of a minor girl, breaking the string of her pyjama and trying to drag her under a culvert does not fall under the category of the crime of attempted rape. Significantly, Allahabad High Court in its order dated March 17, 2025 had said that such acts would prima facie constitute the crime of 'aggravated sexual assault' under the Protection of Children from Sexual Offences Act (POCSO), which provides for lesser punishment. The case pertains to an 11-year-old girl in Kasgani, who was attacked by two men in 2021. This decision of the High Court was under controversy from the very beginning and legal i experts had hoped that this decision would be overturned in a proper manner and justice would be done. In the suo motu proceedings initiated on the controversial remarks made in the Allahabad High Court order, the Supreme Court also issued notice to the Center, Uttar Pradesh government and others. Solicitor General Tushar Mehta also said that it was a shocking decision. The apex court said that the High Court did not pronounce the decision suddenly but after keeping it reserved for about four months. This means that the judge pronounced the decision after proper deliberation. Since the comments reflect a completely insensitive and inhuman approach, it is compelled to ban the comments.However, the apex expressed regret for using harsh words against the judge. In fact, under normal circumstances, the judges of the Supreme Court refrain from staying any decision at this stage. But the important thing that was said while banning the comments made in the referenced decision was that the ban means that they cannot be used further in any kind of legal process. In the opinion of legal should experts, judges restraint.Because such comments reduce people's confidence in the judiciary. The Allahabad High Court's decision has underestimated a heinous crime like attempted rape, which is a mockery of justice. After cases like Satish vs State of Maharashtra, the apex court had condemned the underestimation of sexual crimes. By staying the verdict, the Supreme Court has advised the judges to be more sensitive and humane in such

One prime minister's 19-month legacy is bigger than another's Emergency

wo tumultuous 19-month periods have defined our past over three generations, determined our present and will continue to dominate the future in their very contrasting ways. One is easy to guess. The 19 months of Emergency between 25 June, 1975 and 18 January, 1977. Serendipity, that this column is being written on 21 March, the

day that marks the 48th anniversary of the official

revocation of Emergency.

One set of 19 history-defining months out of the way, can you guess what would be the second? I can make it easier for you. Go back to the tenures of our prime ministers. Not Nehru, Indira, Vajpayee, Modi, V.P. Singh, Gowda, Gujral, Charan Singh. None of these. Since I have already given the riddle away, I will now suggest that we read the just-released biography of Lal Bahadur Shastri written by eminent former IAS officer-turned-scholar Sanjeev Chopra. I had the honour to be among those speaking at the release of The Great Conciliator: Lal Bahadur Shastri and the transformation of India' at the national capital's India International Centre this Tuesday. Between 9 June, 1964 after Jawaharlal Nehru's death and his own tragic passing at Tashkent on 11 January, 1966, Shastri also served for exactly 19 months. And why do we argue that these were as consequential for India's political evolution as the Emergency if in entirely contrasting ways? Think of a mere 19 months when India fought a full-fledged war (September, 1965), a localised skirmish with tanks (Kutch April-July 1965), dealt with crippling food shortages, a difficult political transformation and built more institutions than in any comparable period in our history. The high point of the 19 Shastri months was, of course, the 22-day war that he fought against great odds and won in principle, even if military historians often call it a stalemate. A stalemate against a much, much better enemy with initiative besides equipment in each dimension of warfare that was at least three notches superior is a victory.

Plus, only one side, Pakistan, had an objective in that war. They saw a great opportunity to conquer Kashmir and lost. It was the last time they had the relative strength militarily and diplomatically to take Kashmir. Shastri's resolve buried that dream forever. The legacy of Shastri is unfairly overshadowed by the peace he made at Tashkent and a visit that also took his life. His true contribution is the war he waged. Field Marshal Ayub Khan and his sidekick Zulfikar Ali Bhutto saw great vulnerabilities in the Indian armed forces reeling under the 1962 debacle, and now caught in frenetic transition.

They were emboldened by the 1963 Hazratbal crisis in Srinagar, misread the political transition from Nehru to Shastri as political instability and then, they checked out India's preparedness and morale with probing raids in the Rann of Kutch (RoK).

As Chopra tells you in his very well-documented account, the Pakistanis also checked out their American masters' response by using the Patton tanks in RoK. Under their larger agreement, they were not allowed to use them against India. But, because the Americans did nothing more than make some pious tut-tuts, they knew they could make the big move on Kashmir.

The result: just a couple of months later was Operation Gibraltar, which involved sending more than 10,000 armed infiltrators into Kashmir. It was named Gibraltar because that was the first foothold

the Islamic conquerors established in Europe. Each infiltrating group was also named after famed Islamic warriors: Tariq, Qasim, Khaled, Salahuddin and, for sure, Ghaznavi. Once these groups pulverised the Indian forces in the Valley, the decisive blow would be Operation Grand Slam, as Ayub named the planned massive tank thrust to take Akhnoor in Jammu, or going for the jugular, as he called it.

He is also recorded as having boasted that 'it is well known that the Hindu morale cannot survive more than one or two hard blows'. In this case, there was also a misreading of the resolve of the leader on the other side. Generals, especially Pakistanis, always have a low opinion of civilians. In this case, given how the thought processes of Ayub and his cohort worked, Shastri's diminutive stature and soft-spoken style strengthened this delusion. Except that inside that frail 5ft 2in frame resided an incredibly strong-willed Indian patriot.

The increasingly successful fightback against the infiltrators was still on when Shastri convened his Cabinet and decided on 3 September, with Pakistani tanks (Op Grand Slam) threatening Akhnoor, the broad outlines of his response were drawn. Significantly it included destroying Pakistan's offensive power built only capturing the minimum territory necessary and returning it after successful completion of the war.

There's much unanimity in India on the outcome of the war. In India, the sore point will also be the return of Haii Pir Pass in the Uri sector.

The UN ceasefire resolution, however, had demanded that both sides return to the Ceasefire Line as it existed on 5 August. Which means the Pakistanis had to vacate Chumb, too. While Pakistan lost its last chance to grab Kashmir, the tactical and territorial picture wasn't as one-sided as believed in Indian folklore. That's what caused the Haji Pir compromise and, probably, Shastri his life at such a young age.

From whispers in 1966 to WhatsApp in present times, Shastri's death has been one of those eternal mysteries and the subject of countless conspiracy theories. The book gives us clarity on two things.

One, that Shastri had already had two heart attacks, in 1959 and then on 5 June, 1964, days before taking over as prime minister. This was the era before statins, stents, bypass surgeries. A third heart attack would be that much tougher to survive.

And the second, that on the day he signed the Tashkent agreement, Shastri was initially cheerful. But as he heard of reactions back home, the 'surrender of Haji Pir' having become the refrain in the press, and finally when he spoke with his daughter and wife, both of whom seemed unhappy, his spirit dropped. Within hours he was gone.

It is ironic and also quite tragic and unfair that while talking about Shastri's legacy, we get bogged down with that war and peace. Or, in the overwhelming 'Jai Jawan' story. His even more long-lasting contribution was on the 'Jai Kisan' front. He initiated the Green Revolution, found C. Subramaniam as his food minister, talent-hunted scientist Dr M.S. Swaminathan and founded India's first central agriculture universities.

More importantly, he reached out to the Americans for collaboration. One of the lesser appreciated sides to Shastri's politics is that he wasn't a man of the Nehruvian Centre-Left. You could call him a man of the Centre, as Chopra does. I would say he was more a leader of the Centre, but leaning a bit to the Right. For evidence, read about his dismay at Nehru blocking Purshottam Das Tandon's election as Congress chief, Shastri's upbringing at Servants of the People Society and learnings from Lala Lajpat Rai. And then, the backing by decidedly Right-wing and pro-West Swatantra Party over his no-confidence motion. Also, check out his speech where he locked horns with his Communist antagonist Hiren Mukherjee's accusation that he was deviating from Nehruvianism. In essence, he said, deviation is what you complain about in the communist system. In democracy, there is change.

There is one enduring Americanism I repeat often: the only legacy you leave behind is people. In case of Shastri, I will rephrase that. An even better legacy for a great public figure to leave behind is the institutions

Farmers' deputation meets Sat Sharma over Tractor Tax issue

The Irrigation and Flood Control Department today clarified that the desilting of Escape Channel of the Ranbir canal originating at Bhagwati Nagar is being started in the next 2 to 3 days.

Responding to a News about appearing a section of press reporting on poor sanitation, the Department clarified "The Escape Channel besides playing a vital role in protection of MRC structure during flood season also feeds Bhadrore Supply channel, Bhadrore khul and

Seora khul to provide irrigation to 600 Ha of CCA falling in 2 villages viz. Bhadrore and Seora which is minor as compared with the total CCA of 38000 Ha of the entire Ranbir canal.

As per the past practice, the desilting work of the Escape channel and these khuls is done in the month of April every year as the farmers along these khuls do not allow passing the vehicles through their fields in view of the standing wheat crops and water is supplied to them ending April as per their demand.

Moreover, the initial 300m stretch of the escape channel, which came

into the alignment of the piers of the flyover near Bhagwati Nagar under construction by the NHIDCL, has not been reconstructed by them till date as per the agreement despite repeated requests.

NHIDCL will make some temporary arrangements by construction of an earthen channel, which shall be completed within a day or two as assured by them.

Accordingly, the work of desilting of the Escape channel between RD 320 m to 1350 m and the associated khuls will be taken up within 2-3days and shall be completed next week."

LMD penalises E-Commerce Platform for Labelling Violations in Jammu

THE KASHMIR TALK BUREAU JAMMU:

On the directive of Controller Legal Metrology J&K Anuradha Gupta, the field staff of Legal Metrology, Consumer Protection Unit, Jammu imposed a penalty of ?1.50 lakh on a prominent e-commerce platform operating in the region.

The step is a significant move to uphold consumer rights and ensure compliance with packaging regula-

The concerned e-commerce platform has recently expanded its services to Jammu by opening stores, including one in Jammu, primarily offering instant delivery of a wide range of products such as groceries, fresh fruits, vegetables, meat, stationery, bakery items, personal care, baby care, pet care products, snacks, and flowers.

The action was initiated following an inspection by the area Inspector, under the supervision of Assistant

Controller Consumer Protection Jammu. During the inspection approximately 1200 packages were seized for failing to meet mandatory labelling requirements as stipulated under the Legal Metrology Act, 2009 and the Legal Metrology (Packaged Commodities) Rules, 2011.

The main violation includes nondeclaration of exact net weight of pre-packaged fruits and vegetables for sale through the e-commerce

Upon issuance of a show cause notice, the company acknowledged the offence and promptly submitted application for compounding of the offences which led to imposing a penalty and settling of case at department level on assurance of immediate corrective measures to align with the prescribed labelling norms.

Following the department's intervention, the e-commerce platform has removed the non-compliant products from its physical store shelves for re-labelling and has unlisted the violating items from its online platform to prevent further consumer inconvenience.

A spokesperson from Controller Legal Metrology Department, J&K emphasized the department's unwavering commitment to protecting consumer rights and ensuring fair trade practices. This action is part of an ongoing initiative directed by the Legal Controller Metrology Department J&K to regulate e-commerce platforms, especially in light of evolving trade dynamics and technological advancements which has necessitated enhanced enforcement strategies.

Consumers are encouraged to remain vigilant and report any discrepancy related to product labelling or other unfair trade practices pertaining to Legal Metrology. The Legal Metrology Department assures the public of its dedication to fostering a transparent and consumer-friendly marketplace.
